## Park Sydney Village is privileged to be a part of a supportive and creative community full of diverse cultures and influences.

We endeavor to celebrate this diversity throughout our centre by creating a collection of murals to cover our currently blank walls.

To ensure that this project truly reflects the community we feel that there is no better way to source our artworks than from the community itself allowing them to share their vision with the wider community.



The goal of these murals is to create a sense of vibrancy within the centre, highlighting the iversity and talent seen within the local community.



## The Opportunity

Park Sydney Village is seeking Expression of Interest (EOI) from members of the local community to propose an artwork which can be placed on one of the walls within the centre.

Whilst the final mural will be in the form of traditional paint, artists of all two dimensional mediums are invited to showcase their creative and innovative designs, new ideas and sustainable practice.

Artists may submit an artwork either as an individual or as part of a group via a Submissions Package that includes:

- An Artist's/group statement
- A unique concept that is at least A4 in size that relates to the Erskineville environment/community.

The Submissions Package must be digitally submitted by end of day Friday 12th April 2024 via email to info@designmarketing.com.au

#### The winning individual / group agree's to:

- Be available to discuss the submission at a pre-determined times.
- Be open to collaborate with an artist specified by Park Sydney Village.

From 15th April 2024, The Park Sydney Village team will review all submissions and select one concept for suitable walls amounting to up to 5 selected concepts.

The selected artists will be notified and the artwork installation period is planned to take place May 2024.

All materials & costs to execute the winning concepts in-centre will be funded by Park Sydney Village.

The winning submissions will be published on social media channels along with photographs of the finished murals to encourage community engagement and feedback.

### Locations

There are 5 walls that are potential mural locations situated throughout the centre. Submissions are invited to respond to any or all spaces, noting that all ways may not be utlised.

- 3 murals locations surrounding the travelator
- 1 mural location is in the Parents Room
- 1 mural location is opposite to Mizuki Sushi.
